2/2/2023 – 2/8/2023

Incident Information: 2/2/2023
<p>Misconduct 2/2/2023 1:00 PM</p> <p>Several OJC occupants repeatedly refused directions to lockdown to their cell assignments.</p>
<p>Misconduct / Use Force 2/2/2023 2:48 PM</p> <p>An OJC occupant was observed being irate in an interview room. OJC staff attempted to de-escalate the occupant to no avail. The occupant became combative toward OJC staff. OJC staff then used a takedown technique to bring the combative occupant to the ground. The OJC staff was then able to place restraints onto the occupant. The occupant became compliant once restrained and brought to their feet. The occupant was then escorted to medical for examination and clearing before returning to their cell assignment.</p>
<p>Misconduct 2/2/2023 7:00 PM</p> <p>An OJC occupant flooded their cell.</p>
<p>Contraband 2/2/2023 8:06 PM</p> <p>An OJC occupant was observed in their cell in possession of a lit wick. When OJC staff attempted to confiscate the wick, the occupant flushed it.</p>
<p>Misconduct 2/2/2023 7:50 PM</p> <p>An OJC occupant was observed making inappropriate gestures from within their cell.</p>
<p>Contraband 2/2/2023 10:34 PM</p> <p>An OJC occupant was observed in their cell in possession of a lit wick. The wick was confiscated.</p>
<p>Medical 2/2/2023 2:20 PM</p> <p>An OJC occupant was observed with a cut on their face. The occupant stated that the cut came from an attempt to leave their cell as the door was closing and the door caught them. The occupant was escorted to medical for examination. It was determined that the occupant needed to be routed to University Medical Center for further treatment.</p>

<p>Contraband 2/3/2023 1:05 PM</p> <p>An OJC occupant was observed in possession of a lit wick.</p>
<p>Use of Force 2/3/2023 12:00 PM</p> <p>An OJC occupant refused to leave their cell to be processed for release. After several verbal attempts by OJC staff and medical personnel to de-escalate the occupant, OJC staff used OC spray into the cell to subdue and restrain the occupant. OJC staff then extracted the occupant from the cell, cleaned them up and escorted the occupant to their release.</p>
<p>Inmate on Inmate Altercation 2/3/2023 5:00 AM</p> <p>Two OJC occupants were involved in an altercation within their cell. OJC staff separated the two. One of the occupants requested a cell reassignment due to the incident.</p>

Incident Information: 2/4/2023
<p>Use of Force 2/4/2023 4:20 AM</p> <p>An OJC occupant appeared to be under the influence of an unknown substance while refusing to comply with directives in completing their booking process. The occupant became irate and combative. OJC staff were able to restrain the occupant and escort them through the remainder of their process. The occupant refused medical attention.</p>
<p>Inmate on Inmate Altercation/Contraband 2/4/2023 12:07 PM</p> <p>An OJC staff member observed an OJC occupant attempting to conceal an item in their hand. Another occupant attempted to retrieve said item. OJC staff removed the concealing occupant from the pod and proceeded to lock the remaining occupants down. It was found that a physical altercation had occurred between three occupants and that one of those occupants had used the item against the other two. Other occupants on the pod were</p>

involved in attempting to conceal the item. All occupants were escorted to medical for examination and clearing before returning to their housing assignment.
Misconduct 2/4/2023 6:45 PM
An OJC occupant was observed having a verbal altercation with another occupant. The altercation became physical when one occupant threw their food on the other. A third occupant joined the physical altercation by fighting with the initial aggressor. The occupants were separated and the pod was locked down.

An OJC occupant was being searched after acceptance into OPSO custody. It was found that the occupant had items on their person that are not allowed in the facility.

An OJC occupant repeatedly refused directives to lockdown to their cell.
Inmate on Inmate Altercation 2/5/2023 7:09 PM
Two OJC occupants were observed engaging in a verbal altercation. The altercation quickly turned physical when one struck the other. Shortly after, a third occupant joined in defending the occupant that was hit. All occupants involved were escorted to medical for examination and clearing before returning to their pod.

OJC staff were made aware of a physical altercation on the pod between two cellmates. Both occupants were escorted to medical for examination and treatment prior to returning to their pod.

An OJC occupant was observed inflicting harm to themselves. The occupant was restrained and a mental health profession was notified to speak with them. The occupant refused to cooperate with the interview. The occupant was then reassigned to a self-harm security cell where they can be monitored and prevented from any other attempts of self-harm.

The occupant, currently in the interlock, attempted to push past the OJC staff members and an altercation ensued. OJC staff members restrained the occupant and escorted them back to their cell assignment to lockdown.
Inmate on Inmate Altercation 2/7/2023 11:35 AM An OJC occupant was observed striking another occupant several times. The occupants were separated and escorted to medical for examination and clearing before returning to the pod.
Criminal Damage to Property 2/7/2023 7:25 PM An OJC occupant broke the glass on their cell door.

Inmate on Staff Altercation 2/8/2023 8:20 AM An OJC occupant was being escorted to their court appearance. The occupant became irate, began making threats and inappropriate comments toward OJC staff members. OJC staff members joined in to de-escalate the occupant to no avail. In the midst of the de-escalation attempt, the occupant spit on a staff member. The occupant was separated from the staff member and brought to their court appearance.
